### Reliability

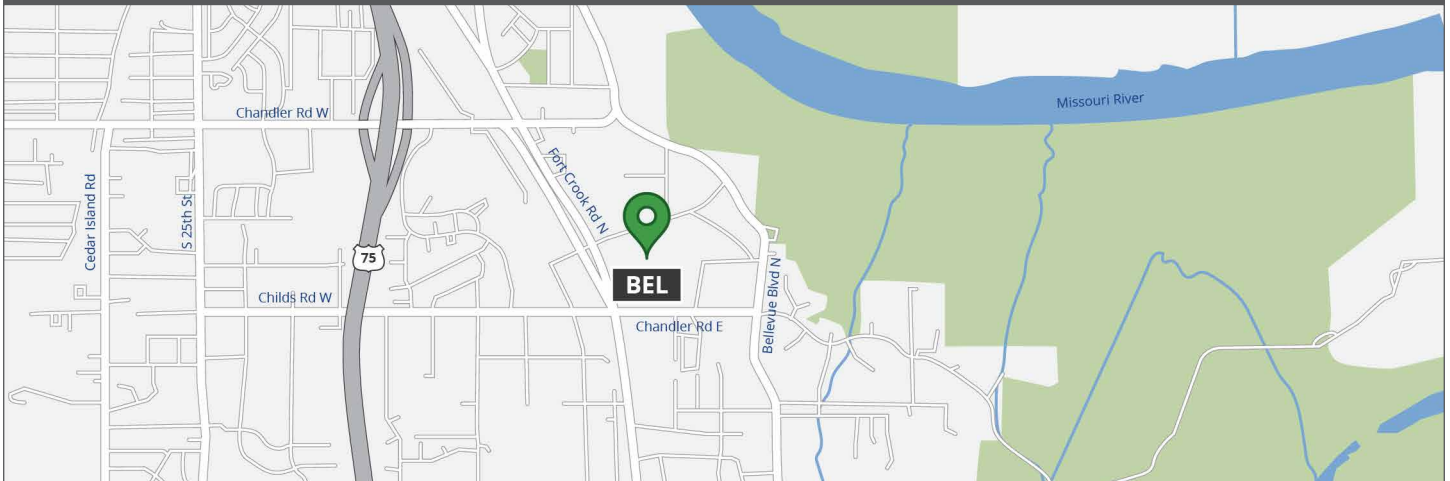
